**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND

Welcome to our gymnastics program. Please read our policies, which for safety and consistency will be strictly enforced.

Initial _____ Enrollment, Tuition, Payment, and Late Charges

- Month to month enrollment is due at the time of enrollment and is good for one (1) full year beginning with the date of enrollment.
- The registration fee and first month's tuition are due at registration.
- The annual registration fee is non-refundable and is good for one year from the day you enroll.
- No refunds will be issued once you begin your class.
- Payments do not vary due to holidays or the number of weeks in a month.
- Tuition payments are due on the first class day of each month and should be paid in the office.
- Prompt payment is expected, and monthly statements will not be sent. **Late charges of \$15.00 will be assessed on the 10th of each month.** Checks returned for NSF will be subject to a \$35.00 processing fee.
- **If tuition has not been paid by the 15th of the month, your child will be dropped from the class.** Once payment is received, (including late fee) the child can be re-enrolled if space is still available.

Initial _____ Student Class Attire

- Girls must wear leotards. No unitards. Shorts may be worn only with the instructor's permission.
- Hair must be pulled back from the face and secured.
- Boys may wear t-shirts and shorts.
- No zippers, snaps, or jewelry may be worn.

Initial _____ Students Arriving and Departing

- Please be on time for class. Warm-up is important in helping prevent injury.
- Pick up students promptly after class.
- We are not responsible for students once they leave our area of the building.

Initial _____ Observation and Conferences

- We welcome parents to observe from our viewing areas.
- Only UEGC staff and students are allowed into the gym areas. If you need to communicate to your child or an instructor during class time, our office staff will be glad to do so for you.
- Conferences are by appointment only, and may be scheduled with the director or instructor.
- We encourage you to be involved with your child's progress in our program.
- Please refrain from talking to your child/children or instructor during class time.

Initial _____ Missed Classes and Dropping

- **Missed classes will not result in prorated tuition or refund.**
- Make up classes will be offered once per month; the first Saturday of every month. You must enroll in the make-up class at the front desk if you plan to attend. We do offer passes to open gym (every Friday 7-10pm) for missed class time.
- Holidays do not count as missed classes and will not be made up.
- Notice must be given to the office if you decide to drop.
